R.25.1 The students of <u>first through final year B.Tech./B. Arch.</u> courses who have registered but failed to clear Institute core courses after obtaining 'E' in the previous semesters may be allowed to register themselves for such courses in the Summer-Term during summer vacation on payment of necessary fees on a specified date. The Summer-Term is a compressed Semester where all the regulations for the normal Semester shall apply but the registration shall be limited to three courses having total credits not exceeding 14.

R.25.2 remains as such.
