Both the students Mr. Lorho Emeo and Mr. Ajay Sharma have not cleared the required credits for continuation of registration as per the Table 4 of UG Course of Study 2006-2007 and as per R.15.2 their enrolment may be terminated. Their credit details are placed at Annexure-I.

# Item No.14-3.9 To consider the case of Mr. Rajarshi Barooah of B. Tech. Information Technology for continuation of registration after completing six years.

Mr. Rajarshi Barooah registered in 2002 in 1<sup>st</sup> B. Tech. yearly scheme and failed to cleared 1<sup>st</sup> year. He again registered in 2003 in new credit scheme as a fresh student and continues till 2007-2008 as per his initial registration he has completed six years. If his 1<sup>st</sup> year is not consider due to old scheme than he may be permitted to clear his remaining course of 10 credits. The details are placed at Annexure-J.

## Item No.14-3.10 To consider the restoring of scholarship for M. Tech. students if required CGPA is attained.

As per Ordinance No. 9 of PG programme "Assistantship to students whose SGPA at the end of a semester falls below 6.50 (6.25 in the case of SC/ST) will be paid only @ 50% of the assistantship. The student whose SGPA/CGPA falls below 5.5 will not be allowed any assistantship. However, M. Tech. students belonging to SC/ST category who lose their assistantship due to SGPA requirement will be given tuition fee exemption". It is proposed that if the student again attains the required CGPA for full assistantship he may be allowed to take full assistantship.
