- 1. Please refer to item number 34-3.20 of minutes vide (2), 5<sup>th</sup> row of the table, this item may be modified as "Scholarship from Research funded external agency" may be replace with "Scholarship from Research funded external agency for all supervisors" currently, the PI gets relief but surprisingly Co-PI if taken as Co-Supervisor get the slot counted!

Please refer to item number 34-3.20 of minutes vide (2) last row of the table, this item may be modified as "Student of other Institute/University guided by MNIT Faculty" may be replaced with "Student of other Institute/University guided by MNIT Faculty excluding CFTIs and the Institutes with whom MNIT has academic cooperation MoU" with this small modification, we will continue to collaborate with other CFTIs and reputed Institutes

#### (ii) **Prof. S. P. Chaurasia-**

In his opinion "the Ph.D. Supervisor/Co-Supervisor and all the DREC members must be Ph.D. holders. As I have understood from the agenda, a provision was proposed that senior faculty members may opt for Supervisor from other departments, in the same way they may also opt for DREC members from other departments.

#### (iii) Shri Ramniwas Sharma-

Please refer to Item No. 34-3.9 –To consider the Ph.D. process for Senior Internal Faculty members of MNIT Jaipur "At item #3 it was pointed out to the house and it was endorsed as well that DREC members should be subject experts and not necessarily have a Ph.D. This is was in particular context of smaller departments like Architecture etc. where there are not enough faculty members with Ph.D. Kindly reword the provisions accordingly".

#### Item No. 35-4.17 : To report the credit variation in curriculum scheme of the Departments.

Matter was discussed in 25<sup>th</sup> SUGB meeting held on 21<sup>st</sup> April 2016 under Item No. 25-2.3 regarding credit variation in curriculum scheme of Departments that the total credits in curriculum schemes vary from 191 to 202 in B.Tech. and are 227 in Architecture including credits of Creative Arts and Discipline. Looking at the wide variation and large number of credits, it was recommended by SUGB that for qualifying for degree the student has to clear all the subjects minimally required as per the schemes of the respective Department. This completion needs be done also for individual categories (PC, PE and OE) of the course.

### Item No. 35-4.18 : To report the new-admission of Mr. Sanjay Sharma (2016REC9063) for Ph.D. in the Department of Electronics & Communication Engineering (Beyond 7 Year).

The matter of Mr. Sanjay Sharma for extension beyond 7 years in Ph.D. program was discussed in the 22<sup>nd</sup> SPGB held on 10<sup>th</sup> July 2015.The matter was not approved by SPGB. The application of Mr. Sanjay Sharma was again forwarded in 23<sup>rd</sup> SPGB held on 26<sup>th</sup> August 2015, the SPGB again did not recommend the extension beyond 7th year. However the candidate is free to apply for re-registration following the due process for admission to Ph.D.

The same matter was discussed in the 33<sup>rd</sup> Senate meeting held on 03<sup>rd</sup> October 2015 under item no. 33-4.16, the below decision was taken by the Senate "The SPGB had turned down the request since there is no provision in R& R for extension beyond 7 year; The Senate approved the recommendation of SPGB"

The recommendation of DPGC of Electronics & Communication Engineering in case of Mr. Sanjay Sharma to present Pre-Ph.D. Seminar and subsequently submit the thesis after termination by the Senate after completion of maximum duration for submission thesis was discussed in the 30<sup>th</sup> SPGB. The case was not considered as his candidature was terminated by the Senate.

Now the matter was again forwarded in Deans Meeting held on 15<sup>th</sup> July 2016 by the Department of Electronics & Communication Engineering, the matter was discussed under item no. 13 and the Deans Committee decided that "*The application of Mr. Sanjay Sharma Part Time Ph.D. Scholar for re-registration seeking exemption* from entrance test, course work and comprehensive exam was discussed and it was decided that *Mr. Sanjay Sharma may be permitted new registration without* scholarship and his course work may be waived off without exemption from comprehensive examination"

As per the approval of Deans Committee, Mr. Sanjay Sharma (New ID: 2016REC9063) has been admitted as a Full Time candidate on 17<sup>th</sup> August 2016 in the Department of Electronics & Communication Engineering.

### Item No. 35-4.19 : To take note of the revision in Fee Structure applicable for UG, PG and Ph.D programme being run at MNIT, Jaipur.

The Department of Higher Education, MHRD, Govt. of India vide its order F .No.33 – 4/2014 - TS.III dated 24.06.2016 and 02-07-2016 (placed at **Annexure AC. 202-205**) has approved the revision in the tuition fee of NITs from the Academic Session 2016-17.

In light of the above, fee structure for U.G., P.G., Ph.D. students of all categories were revised as per the approval/decision of the authorities. Revised Tuition and Institute fees etc. have been charged from the students of all categories admitted in academic year 2016-17. #### Item No. 35-4.21 : To ratify the relaxation of (N-4) rule of UG Regulation 13.3.

Some students were facing problem due to the (N-4) rule. The DUGC of the Chemical Engg. and Electronics & Comm. Engg. Dept. strongly recommended to relax it and the matter was discussed in the 15<sup>th</sup> AAC meeting held on 26<sup>th</sup> July 2016 and the Committee recommended that this rule may be relaxed for those students who are not academically deficient i.e. CPGA $\geq$ 5.00 and recommendation approved by the Chairman Senate. Accordingly permission has been granted to all students for registration in current semester.

Item No. 35-4.22 : To ratify the registration of UG students of 2013 Batch whose CGPA is less than

#### 5.0 or greater than 4.5 for the last three years.

The matter regarding **07** students who achieved a CGPA of > 4.5 and < 5.00 in the VI Semester was placed in the 15<sup>th</sup> AAC meeting and it was decided to get them registered as academically deficient students as per the promotion policy followed after the III Semester for academically deficient students. The list is placed at **Annexure-G** (**Pg.66**)

Matter is placed before the Senate for ratification.

### Item No. 35-4.23 : To ratify the registration of UG students of 2014 Batch whose CGPA is less than 5.0 or greater than 4.5 for the last three years.

The matter regarding **09** students who achieved a CGPA of > 4.5 and < 5.00 in the VI Semester was placed in the 15<sup>th</sup> AAC meeting and it was decided to get them registered as academically deficient students as per the promotion policy followed after the III Semester for academically deficient students. The list is placed at **Annexure-H** (**Pg.67**)

### Item No. 35-4.24 : To ratify the registration of the UG students for one semester/one year extension to complete their degree beyond six years.

- (i) Karmveer (2010UMT170) requested to extend one semester beyond 6 year to clear his only one open elective. He earned total of 178 credits with 5.23 CGPA and has one course CH-212 as backlog.
- (ii) Amit Bikunia (2010UME238) has complete 6 years of his B. Tech. programme and requested for extension of one semester to complete all requirements for the award of degree. Mr. Ajay Yadav again requested to reconsider his case based on revised CGPA grade point 4.82 after supplementary examination 2016. On recommendation of Head, Dept. of Met. & Mat. Engg. matter was placed in 16<sup>th</sup> AAC meeting held on August 30, 2016 under Item No. 16-9.0. AAC permit Mr. Ajay Yadav for one year extension to complete his degree.
