27. **Buyer Added Bid Specific ATC**

1. It may be noted that benefit of EMD exemption and purchase preference to MSME will be given only to the manufacturers for the respective g

oods and service providers for respective services. Any trader including authorized dealer of OEM submitting MSME certificate will not be considered under MSME category for this bid and these benefits will not be applicable to such firm.

2. For EMD exemption, if firm doesn't claim under relevant category, his EMD exemption claim will not be considered and the bid will be rejected . *For example if a firm wants to claim EMD exemption on the basis of MSME Udyam Certificate, the firm has to claim EMD exemption under 'MSME Category' option on Gem Portal. If the firm claims exemption under any other category and submits MSME Udyam Certificate, his claim will not be considered and the bid will be rejected.*
